

**ALIANZA COACHELLA VALLEY  
YOUTH PROGRAMS WAIVER AND RELEASE**

*PLEASE READ CAREFULLY*

All program participants who wish to participate in Alianza Coachella Valley’s (“Alianza”) youth programs (“Youth Programs”) must first read and sign this waiver and release prior to participation. In consideration for participation in Alianza’s Youth Programs, you will be expressly assuming the risk and legal liability, in addition to waiving and releasing all claims, for injuries, damages, or property loss which you may sustain as a result of participating in Alianza’s Youth Programs. This includes, but is not limited to, claims for injuries, damages, or property loss sustained while participating in Youth Program events, and while being transported to and from Youth Program events in vehicles owned and/or operated by Alianza staff, volunteers, and/or Alianza organizational partners (“Transportation Services”). In addition, all program participants must agree to the release of their name, image, and/or likeness for advertisement, marketing, social media, or other purposes deemed necessary by Alianza.

**1. Assumption of the Risk**

I, or as the parent/guardian of a minor, recognize and acknowledge that there are certain risks of injury, damages, or property loss as a result of participation in Alianza’s Youth Programs and/or receiving Transportation Services to and from Youth Program events. I, or on behalf of a minor, voluntarily agree to assume the full risk of any injuries, death, accidents, damages or loss, regardless of severity, that I, or the minor, may sustain as a result of participating in any and all activities or events associated with, related to, or arising out of participation in the Youth Programs and/or Transportation Services provided by Alianza.

I, or as the parent/guardian of a minor, further recognize and acknowledge that I, or on behalf of the minor, will be responsible for any losses of personal property which are a result of participating in any and all activities associated with, related to, or arising out of participation in the Youth Programs and/or Transportation Services provided by Alianza.

**2. Waiver and Release**

I, or as the parent/guardian of a minor, hereby waive, release, and discharge Alianza, including its respective officials, officers, agents, representatives, volunteers and employees, from any and all claims, demands, injuries, loss, or actions which may accrue to me, or the minor, which are arising out of, connected with, or in any way related to participation in the Youth Programs and/or Transportation Services provided by Alianza.

**3. Indemnification**

I, or as the parent/guardian of a minor, agree to indemnify and hold Alianza, including its respective officials, officers, agents, representatives, volunteers and employees harmless from and against any and all claims, demands, injuries, loss, or actions associated with, related to, or arising out of participation in the Youth Programs and/or Transportation Services provided by Alianza. I, or on behalf of minor, will pay all costs incident to any claim, including, without limitation, attorneys' fees.

**4. Photo/Video Release**

I understand that during the Youth Programs and related activities, my photograph and/or the photograph of my child/youth may be taken by Alianza or its officials, officers, employees, volunteers, agents, sponsors, organizers, and/or assigns. I agree that my photograph and/or the photograph of my child/youth, including video photography, film photography, or other reproduction of my likeness or the likeness of my child/youth, may be used without charge by Alianza or its officials, officers, employees, volunteers, agents, sponsors, organizers, and/or assigns for such purposes as they may deem appropriate.

**5. Governing Law**

This agreement shall be interpreted in accordance with the laws of California. Any dispute shall be filed in Riverside County, the State of California, and shall not be transferred to any other state or county. If any clause is found to be invalid, the balance of this Agreement shall be remain in effect and will be valid and enforceable.

**6. Minors**

No minor will be permitted to use a vehicle owned, operated, or otherwise retained by Alianza for Transportation Services without the parent or legal guardian's signature.

I AM AWARE THAT BY SIGNING THIS RELEASE OF LIABILITY I AM WAIVING MY AND MY MINOR'S LEGAL RIGHTS AS DISCUSSED ABOVE. I HEREBY GIVE MY CONSENT AND PERMISSION TO EXECUTE THE ABOVE AGREEMENT AND DO HEREBY AGREE TO BE BOUND BY ALL TERMS AND CONDITIONS ABOVE.
